

### ITEM 1 - INTRODUCTION: IS AN INVESTMENT ADVISOR ACCOUNT RIGHT FOR YOU?

Atticus Wealth Management, LLC is registered with the Securities and Exchange Commission as an investment adviser. Please be aware that brokerage and investment advisory services and fees differ and that it is important for you to understand the differences. Free and simple tools are available to research firms and financial professionals at [Investor.gov/CRS](https://investor.gov/CRS), which also provides educational materials about broker-dealers, investment advisers, and investing.

### ITEM 2 – WHAT INVESTMENT SERVICES AND ADVICE CAN YOU PROVIDE ME?

We offer investment advisory services to retail investors. Our principal services include portfolio management, pension consulting and financial planning. As part of our standard portfolio management service we provide continuous and regular supervisory and/or management services with respect to your account(s). We do not monitor the investments made as a result of pension consulting or a financial plan unless you have hired us for portfolio management services. Our portfolio management services are offered on a *discretionary* basis. *Discretionary* authorization allows us to determine the specific securities, and the amount of securities, to be purchased or sold for your account without your approval prior to each transaction. We **do not** limit our advice to proprietary products, or a limited menu of products or types of investments. In general, we require a minimum of \$500,000 to establish a relationship with us. At our discretion, we reserve the right to waive this minimum.

### ITEM 3 – WHAT FEES WILL I PAY?

We are primarily compensated by a percentage of assets under our management and/or hourly fees. Our fees vary depending on the services you receive. Portfolio management and pension consulting fees are based upon a percentage of your assets under our management and are payable either daily, monthly or quarterly in arrears depending upon the arrangement. The more assets there are in your advisory account, the more you will pay in fees. Therefore, our revenue grows or declines with your account balance. Additionally, we have an incentive to encourage you to increase the assets in your account. We provide financial planning and pension consulting services for an hourly fee. Our fees are negotiable depending upon the complexity and scope of the service, your financial situation, and your objectives.

**Description of Other Fees and Costs:** The fees that you pay to our firm for investment advisory services are separate and distinct from the fees and expenses charged by investment companies (e.g., mutual funds, exchange traded funds, and unit investment trusts). These fees are described in each fund's prospectus. These fees will generally include a management fee and other fund expenses. You might also incur transaction charges and/or brokerage fees when purchasing or selling securities. These charges and fees are typically imposed by the broker-dealer or custodian that executes the trade. The broker-dealer or custodian may also charge your account for custodial fees, retirement account fees, trust fees, exchange fees, redemption fees that may be assessed on investment company shares, transfer fees, account termination fees or other special service fees and charges. We do not share in any portion of these fees imposed by the broker-dealer or custodian. To fully understand the total cost you will incur, you should review all the fees charged by investment companies, broker-dealers, our firm, and others.

**You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.**

**What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?**

*When we act as your investment adviser, we have to act in your best interest, not ours. When we provide investment advice to you regarding your retirement plan account or individual retirement account, we are fiduciaries within the meaning of Title I of the Employee Retirement Income Security Act and/or the Internal Revenue Code, as applicable, which are laws governing retirement accounts. We must put your interest ahead of your own. At the same time, there always remains the potential for conflicts of interest to arise. It is our policy and responsibility to discuss any conflict of interest that might arise with you. Here is an example to help you understand what this means:*

All investment advisers face conflicts of interest which are inherent in the business. Our primary source of compensation is through asset-based fees. Therefore, we are incentivized to acquire new clients and to increase assets under management.

Conversation Starter. Ask your financial professional—

- How might your conflicts of interest affect me, and how will you address them?

#### **How do your financial professionals make money?**
